#### LET'S GET MOVING - WHAT IS SHARED OWNERSHIP?

Buying a shared ownership home has never been simpler. If you can't afford to buy a property outright, our shared ownership scheme (or low cost home ownership) will be a great option for you. Our shared ownership scheme allows you to buy a percentage of your home and rent the remainder from us.

Over time you can buy bigger shares in your home until you own it all. At which point you won't have to pay us any rent - this is called staircasing. You could buy a shared ownership home through Help to Buy if your household earns less than £80,000 a year, you are a first time buyer or used to own a home but can't afford to buy one now. To be eligible for shared ownership, you must register at www.helptobuyese.org.uk
